Treatment under local anaesthetic, relative analgesia, intravenous sedation and general anaesthetic are all provided within the Oral Surgery department and DCT's will be involved with treatment</p>

They attend consultant-led clinics, seeing new and review patients, carry out investigations including mucosal biopsies and blood tests and have an important part to play in checking the results of investigations and taking action on any abnormalities identified. They also participate in departmental meetings, audit projects and prepare presentations for journal club meetings. DCTs are encouraged to attend regional and national oral medicine meetings and to present cases and posters.</p> <p>All DCTs also gain experience in managing patients with complex medical histories.</p>
