Old Age Psychiatry, Lincolnshire Partnership Foundation NHS Trust Lincoln

The FT2 post is based at the acute in-patient Unit in Witham Court, North Hykeham, Lincoln. There are 2 wards, one functional (Brant ward) and one organic/dementia (Langworth ward).

Inpatient Placement (Witham Court, Fen Lane, North Hykeham, Lincoln)

This interesting and varied post provides fantastic exposure to Older Peoples Mental Health Services. This is a post with experience gained by working across two acute admission wards.

The functional ward accepts admissions from the whole of Lincolnshire for older people with acute functional psychiatric disorders such as depression, anxiety, schizophrenia, bipolar disorder and other acoute and enduring mental health problems. This ward has a total of 20 beds.

The organic ward is primarily for adults (any age) suspected to have dementia and older adults with a range of primary neurodegenerative brain disorders and dementias. Most admissions are for acute assessment and management of behavioural and psychological problems in the context of the organic illness. There is a wide range of multidisciplinary work within this unit and trainees gain a lot of experience in the care of patients with a lot of long term conditions. This ward has 17 beds. The FT2 doctor will have the opportunity to sit in outpatient clinics run by the Consultant and conduct joint home visits to patient's homes/care homes with other team members.

Both units are staffed by experienced Nursing, Occupational therapy, Physiotherapy, and Psychology colleagues. In addition, there are 3 Liaison Nurses based within the acute hospital that are also part of the service. There are plans for GP colleagues to support both units given the high rates of medical comorbidities.

The medical team comprises of a three full-time Consultant Psychiatrists (Dr Esiwe, Dr Anand and Dr Allam) one Psychiatry Core- Trainee and two Specialty Doctors. These doctors also work within 3 separate community mental health teams and hence are not purely in-patient based.

There is a broad range of experience to be gained in this post. The FT2 will be involved in acute admissions, regular physical examinations and reviews and be a part of the MDT team involved in assessing and managing the patients. The FT2 trainees will have opportunity to review patients individually and to present them at ward round discussions. They will also be expected to liaise with our acute medical colleagues when patients require medical or surgical reviews. There is also some exposure to the work of the community mental health teams on one day of the week.
